


ABOUT TRANSGRID


OUR MILESTONE ACQUISITION

Transgrid Enerco's acquisition of a 60% equity stake in **Eko Electricity Distribution Company (Eko DisCo)** is a landmark achievement. This transaction, Nigeria's first market-driven power sector acquisition, positions Eko DisCo to increase its electricity distribution capacity from 513MW to 1,500MW in a few years.
